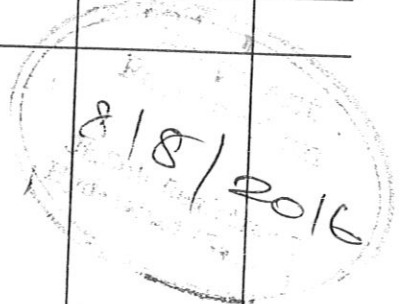

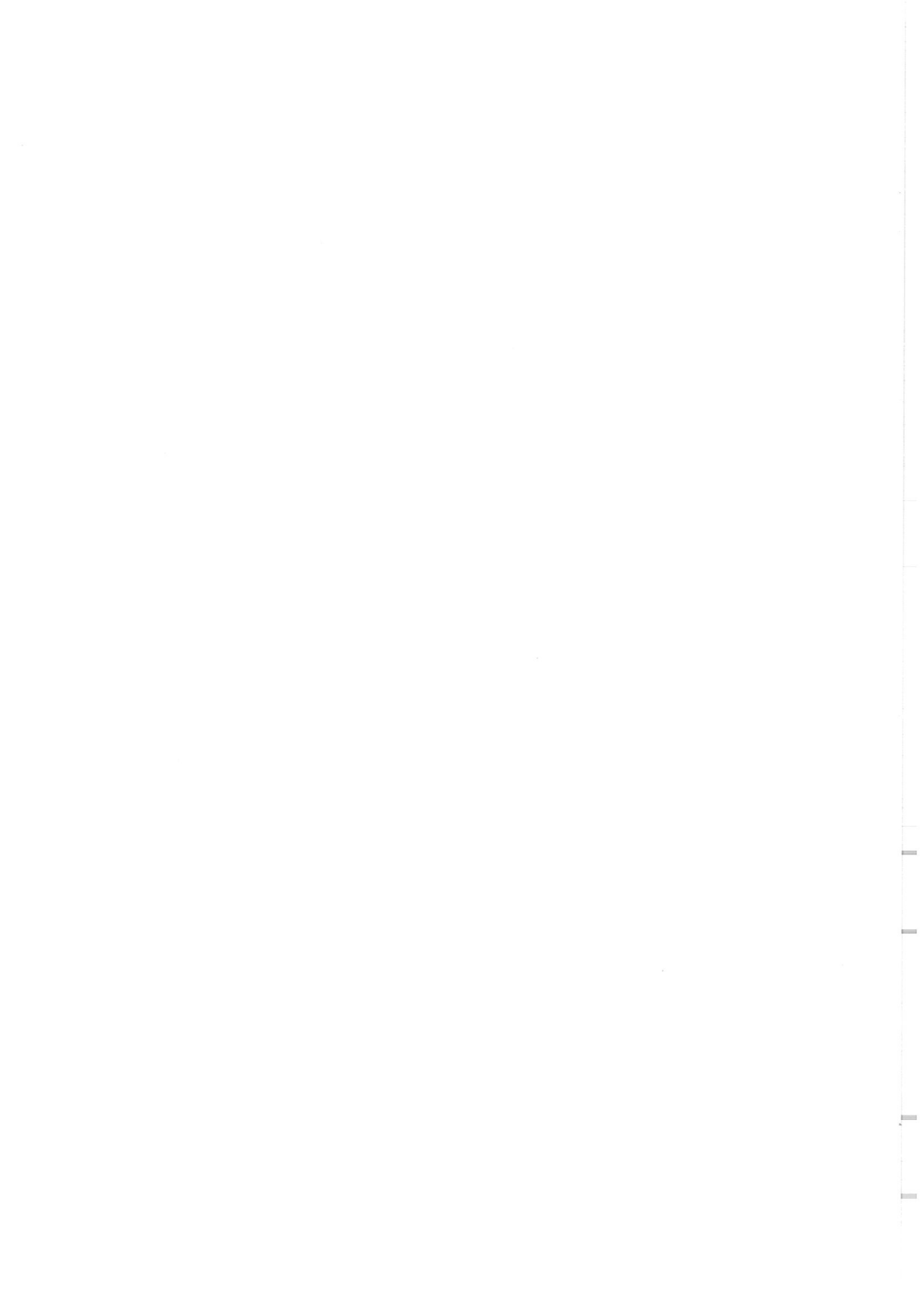

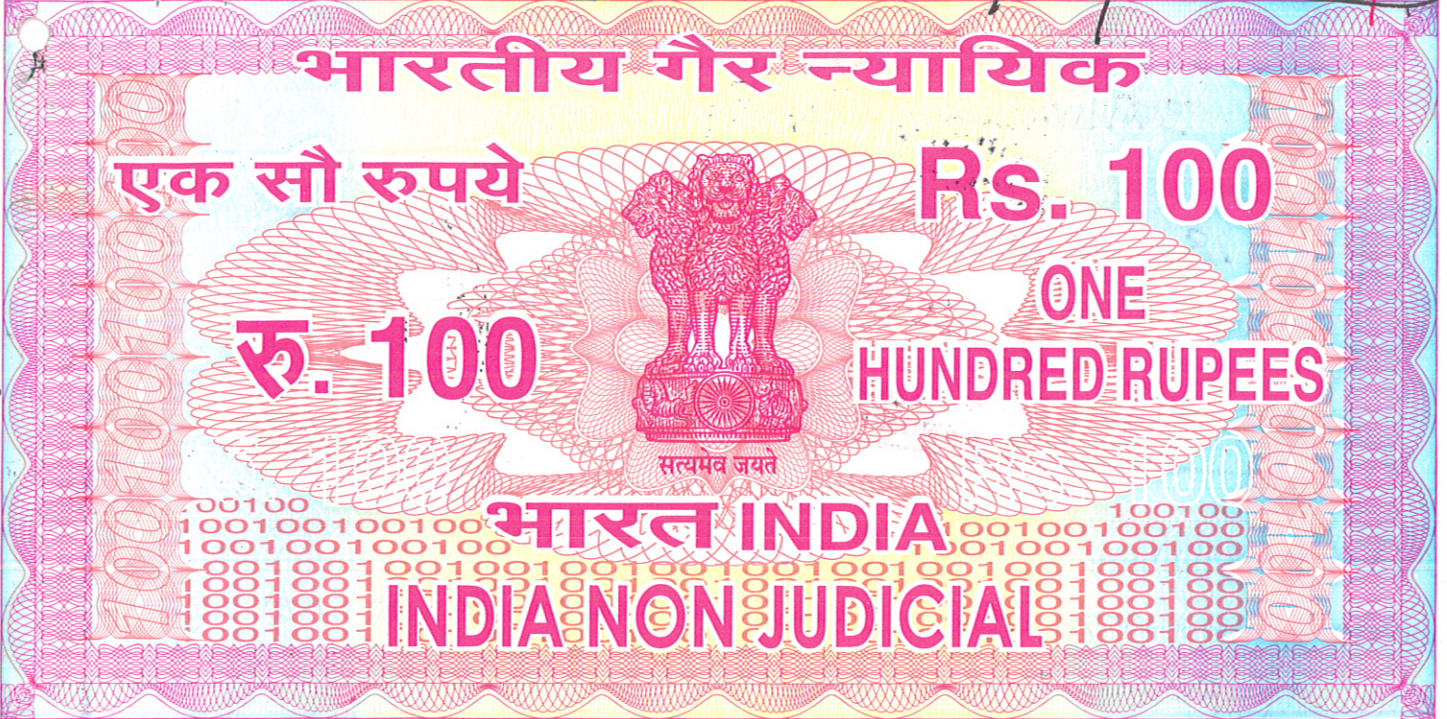

WHEREAS the Settlers herein and their respective family members have been considerably involved in various philanthropic activities and are desirous of establishing and creating an Educational Trust to achieve the objects and purposes mentioned hereunder.

AND WHEREAS the Trust is hereby expressly declared to be a charitable Trust and all the provisions of this deed are to be constituted accordingly.

AND WHEREAS it is necessary to declare the objects and terms of the charitable trust being constituted under these presents.

WHEREAS the "**SETTLORS**" for carrying out Education and charitable purposes have contributed jointly Rs.1,00,000/- (Rupees One Lakh only) as initial contribution towards corpus of the Trust.

Now whereas the Settlers have decided to formalize their charitable intentions and form this Trust under the provisions of Indian Trusts Act 1882 for charitable purposes meant for non-profitable purposes only.

WHEREAS Settlers desirous of forming a Trust for the purpose of establishing and running educational institution/s for imparting education and has, for this purpose contributed a sum of Rs.1,00,000/- (Rupees One Lakh only) towards the corpus of the Trust.

WHEREAS it is now felt by the Settlers of the Trust that they should form and constitute a Trust with the Rules and Regulations framed thereunder for the purpose of accomplishing the aims and objects of the Trust as mentioned in this deed and also to maintain and administer the Trust affairs and properties under the auspices of the Trust; which is hereby declared as irrevocable.

**NOW THIS DEED OF DECLARATION OF TRUST WITNESSETH AS FOLLOWS:**

**1. NAME OF THE TRUST:**

The name of the Trust shall be "**VIDYALOK EDUCATIONAL TRUST**". The Trust hereby declared shall be irrevocable and the beneficiaries under the Trust are the public at large.

**2. PLACE OF THE TRUST:**

The principal administrative office of the Trust shall be at Flat No.E101, Fortune enclave, Banjara Hills, Road No.12, Hyderabad or such other place as the Trustees may from time to time decide. The Trust may also carry on its work at any other place or places, as may be decided by the Trustees from time to time.

**3. TRUST FUND:**

The Settlers hereby settle a sum of Rs.1,00,000/- (Rupees One Lakh only) by way of a Fund (hereinafter called the "Trust Fund" and the expression of 'Trust fund' shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents) in Trust, with the name and for the objects hereinafter stated, by delivering the said amount in cash which the Settlers, the Trustees, have accepted the receipt of which they do hereby acknowledge, to hold the same in and to the Trustees with the powers and obligations as provided hereinafter.

**4. TRUST PROPERTY:**

The expression "TRUST PROPERTY" shall mean and include the initial fund contributed herein before together with further contributions, donations and all the accumulations and accretions thereto and acquisitions from whomsoever and in any manner and whatever form and shall be held in trust for the intent, purpose, aims and objects herein contained and such properties shall vest in the trustees who shall hold and stand possessed of the same for and in the name of Trust.

As on the date of incorporation of the Trust, no immovable property is involved.

**5. OBJECTS OF THE TRUST:**

The objects of the Trust shall be:

- a. To Promote literacy and education and to lay emphasis on pre-primary, primary, Secondary, Higher, collegeate, technical/professional education, etc., and to set-up institutions and establishments for the said purpose.
- b. To impart education, advancement, promotion and spread of education by establishing, maintaining, assisting and supporting of colleges, schools, educational institutions of pre-primary, primary, secondary, higher Secondary, professional, engineering, medical, technical and non-technical institutions, establishing and running hostels, libraries, reading rooms, vocational, technical and social centres allied thereto and/ or other educational institutions;



- c. To establish, run, maintain academic Institutions, support, assist or grant aid or obtain franchise rights from reputed institutions, other financial assistance to schools, colleges, libraries, laboratories, educational or other institution, for use of the students and the staff and also for the development, advancement of education and diffusion of knowledge amongst the public in general or help any existing educational institution/s without profit motive and for the benefit of the public, irrespective of caste, creed, religion, sex, etc, under TRUST or any other name as may be decided by the Trustees from time to time.
  - d. To help the needy students of all communities for the pursuit of studies
  - e. To do all that is necessary such as transportation, catering etc., as an allied activities which are incidental for the purpose of imparting education to achieve the above mentioned objects.
- a) Other objects:-
- i. to acquire property movable or immovable by way of sale or lease for establishing, running the Schools, colleges and educational institutions and its offices, hostels and the premises required incidental thereto.
  - ii. to undertake any other activity incidental to the above activities but which are not inconsistent with the above object.

PROVIDED the Trust may assist/donate to any other TRUST to carry out the various objects mentioned in the objects clause in such manner and to the extent the Trustees may decide upon from time to time.

#### **6. NATURE OF THE TRUST:**

These presents shall constitute an irrevocable trust upon and subject to the provisions of these presents and no part of the Trust funds, whether movable or immovable, in the hands of the Trustees shall be recoverable by the Settlers nor shall any of the settlers have lien or charge of any description whatsoever on the Trust Fund and its properties.

## **7. TRUSTEES:**


The Trustees/ Settlers  
(a) shall be:

- (i) **Ms. AISHWARYA KURRA**, D/o. Sri. K. SRINIVAS RAO, aged 23 years  
Occ: Business, R/o Plot No. 664, Road No.33, Jubilee Hills, Hyderabad,  
Telangana.
- (ii) **MS.INDUKURI SINDHURA**, W/o. Sri. CHALASANI NITIN CHANDRA  
aged 31 years, Occ: Business, R/o E101, Fortune Enclave, Banjara Hills,  
Road No. 12, Hyderabad 500034.

## **8. GENERAL TERMS**

- 1) **The** term and tenure of the Office of the Trustees is for life. Their position be that of a **hereditary** Trustees with right to nominate their successor such as the wife, husband, son, daughter, daughter in law, son in law, grandson or brother, sister, granddaughter by nomination to the Trust which is to take effect either forthwith or after their life time of the Trustees or by nomination of their successors in their will.
- 2) In the absence of nomination or in the will or in case of sudden demise of the Trustee, his/her legal heir(s) shall be nominated as the Trustee of the Trust in the place of the Trustee on recommendation of spouse of demised Trustee to fill up the vacancy which shall be ratified at the succeeding meeting of the Board of Trustees.
- 3) If no such nomination is made or in case no recommendation from the spouse of the deceased Trustee is received for unforeseeable reasons whatsoever, the next legal heir(s) of the deceased Trustee would be taken in his/her place and such Trusteeship shall be ratified at the succeeding meeting of the Board of Trustees.
- 4) In the event of such legal heir(s) being a minor, he/she shall be represented by his/her guardian till such time he/she attains 18 years of age.
- 5) Nomination can be changed during the Trustee's Life time, if he/she so desires during his/her life time.
- 6) The right of nomination shall pass on to the successor's nominee.

- 7) The maximum number of Trustees shall not exceed Five (5). However, the number of Trustees can be increased by the majority of Board of Trustees.
- 8) Any Trustee may relinquish his/her office as Trustee on giving one month's notice in writing to the Board of Trustees and upon the expiry of such period of one month, he/ she shall cease to be a Trustee of the Trust.
- 9) Any vacancy for any cause whatsoever arising among the Trustees shall be filled in by the Board of Trustees.
- 10) A Trustee shall automatically vacate the office of the Trust on the happening of any of the following:
  - If he/she is of unsound mind
  - If he/she is adjudicated insolvent or if he/she applies to be adjudicated insolvent.
  - If he/she is convicted of an offence involving moral turpitude and is sentenced thereof to imprisonment for not less than six months.


#### **9. POWERS & FUNCTIONS OF TRUSTEES**

That the trustees shall have the following powers:

- 1) To carry on day to day and regular management of all the affairs relating to the Trust or the institution established and run by it and their overall supervision and administration thereof
- 2) To look after and regulate all the affairs for proper administration and management of the assets, movable and immovable properties of the Trust or/and the institutions established by it.
- 3) To appoint employees, staff, teachers, faculty including all kinds of human resources either on permanent basis or temporary basis as may be required from time to time for conducting overall administration of the affairs of the Trust and/or the institutions established by it, to fix their remuneration and other attendant benefits, service conditions, code of conduct including termination of their service and to settle the terms of their service.
- 4) To appoint Advocates, Chartered Accountants and other professionals as may be required from time to time for availing their services in the affairs of the Trust and to fix their remuneration.

- 5) To sign and enter in to any Agreements with the existing reputed Institutions to enable the Trust to inturn establish the Educational Institutions by adopting, borrowing and implementing the educational programs as may be permitted by such institutions by using and utilizing their copy right, trademark, project management services, franchise etc., as per the mutual terms and conditions as may be agreed from time to time among such Institutes and Board of Trustees.
- 6) To enter into and execute and register Lease Agreements/Deeds with the owners of the premises for obtaining lease of the premises either for Trust or for the educational institutions established by the Trust.
- 7) To enter into and execute any agreementsas may be required such as service Agreements, consultancy Agreements, outsourcing Agreements, Supply Agreements, Work orders, maintainanceagreements with other entities for effective implementation of the objects of the Trust and for proper and effective administration of the educational Institutions of the Trust.
- 8) To invest the funds of the Trust by way of deposits in to the Bank or for acquisition of movable and immovable properties for and in the name of the Trust
- 9) To open any accounts such as Savings Bank Account, Current Account, Fixed Deposit Account, Recurring Deposit Account or any other Accounts in any Banks or Financial Assistance for and in the name of Trust and either of the existing trustees or their authorized representative from time to time, duly authorized in this behalf, shall be empowered and authorized to operate all such bank accounts including deposit and withdrawelof the amounts from such Bank accounts.
- 10) To approach the Banks, financial Institutions and third parties for availing loans/financial Assistance to meet the time to time requirement of term loans or working capital loans for establishing educational Institutions and for running the same and for such purpose the Board of Trustees or any of the Trustees being authorized by the Board of Trustees are authorized to execute loan documents from time to time in favour of such lenders and further authorized to create mortgage on the Trust properties in favour of such Lenders as a security for repayment of such loans.

- 11) To sell, alter, vary, transpose or otherwise dispose or alienate, lease out the movable and immovable properties of the Trust or any investment representing the same for any consideration/lease rentals as the case may be as may be decided by the Board of Trustees and to utilize such sale/lease proceeds either for affairs of the Trust or towards reinvestment for acquisition of movable and immovable properties;
- 12) To pay all charges, impositions and other outgoings payable in respect of the Trust properties and also to pay all amounts incidental to the administration and management of the Trust properties;
- 13) To protect the interest of the Trust and its properties, to initiate legal actions/proceedings if required against third parties or to defend any legal proceedings brought against the Trust and for such purpose, the Board of Trustees either can appoint and authorize any of the Trustee or its senior employee to represent the Trust in all respects in such legal proceedings by way of a Resolution passed to such effect.
- 14) To accept any gift, donation or contribution in cash or in kind and by way of property or annual or monthly subscription for the benefit of the Trust in the name of the Trust for fulfillment of the objects of the Trust. The Trustees shall apply such contribution in accordance with the objects of the Trust.
- 15) The overall Management and control of the property and affairs of the Trust aforesaid shall be vested in the Trustees with full powers and authority to purchase or hold any land or property and construct any building for achieving the objects of the Trust. It shall be lawful for the Board of Trustees from time to time to frame such rules and regulations for the management and administration of the Trust and charities as they deem fit and to alter or vary the same from time to time to make new rules and regulations provided such rules and regulations shall not be inconsistent with the terms and intents of these presents and not inconsistent with the provisions of the Income-tax Act, 1961.
- 16) To manage Trust Funds and collect and recover the interest, income and profits thereof and to pay there out the expenses of collection and other outgoings, if any.

- 17) The Trustees shall have the powers specifically conferred to do things as may be required for the proper conduct of the affairs of the Trust from time to time in the interest of the Trust if such powers are not specifically conferred herein.
- 18) At all meetings of the Trustees, all the members will form the quorum. If quorum is not present at any such appointed time, the meeting shall be adjourned to the same day of next week and at the same time. If quorum is not present even at such adjourned meeting, the Trustees present shall constitute sufficient quorum.
- 19) The Trustees shall have the right to pass necessary resolutions by circulars instead of by meetings and any resolution as agreed to by a majority vote of the Trustees shall be as valid and effectual as a resolution of the Trustees at a meeting duly convened.
- 20) The Trustees shall determine all questions and matters of doubt in the execution of the affairs of Trust including the meaning and constructions of any of the articles and provisions herein contained.
- 21) The Trustees shall also be entitled to incur all legitimate expenses which they consider to be beneficial to the interest and welfare of the Trust.
- 22) All proceedings of the meeting of the Trustees shall be recorded in a Minutes Book kept for the purpose.
- 23) To invest the funds of the Trust in such manner as permissible under Sec.11(5) r/w Sec.13 of the Income-tax Act,1961 as may be amended from time to time or any other law so made in respect of the same, so as to ensure exemption from taxation.
- 24) These powers of the trustees shall be so exercised as to ensure that the income of the trust would be exempt under Sec.11 or any other relevant section(s) as read with Secs.12, 12A and 13 or any other relevant provisions of the Income-tax Act, 1961, as amended from time to time or any other law made in respect of the same.

- 25) It is clarified that the power of investment of the trust funds including those mentioned in clause 6 (c) and the powers of application/accumulation of the funds of the trust for charitable purposes shall be exercised in accordance with the provisions of the Income-tax Act,1961 including Section 11(5) in a manner which will not attract disentitlement of Income tax exemption under Sec.13 of the Income tax Act,1961 or any other provisions of that Act, as amended from time to time, or any other law made in respect of the same.
- 26) No business shall be carried on by the Trust unless such business is incidental to the attainment of the objects of the trust. Separate Books of Account shall be maintained by the trust, in case such business is carried on, as required under the provisions of Sec11(4A) of the Income-tax Act,1961, as amended from time to time or any other law made in respect of the same.
- 27) The Trustees shall at all times stand personally indemnified in respect of any act, thing or deed that they may have performed, done or executed bonafidely in respect of affairs relating to the Trust in good faith.
- 28) All the Trustees collectively by majority decision are empowered to alter the provisions of this deed including the rules governing the administration of the Trust in a manner not inconsistent with the objects of the Trust and inconformity with Income Tax Act, 1961.
- 29) The Trustees shall meet as often as possible but not less than three times in a year for efficient management of the affairs of the Trust to consider the income and expenditure and for disposing of all such other matters as may arise in such meetings.
- 30) Notice for every meeting of the Trustees stating the general nature of the business to be considered thereat shall be delivered to or sent by post or by e-mail to each of the Trustees at least fourteen calendar days before the date of such meeting. A meeting can be called at a shorter notice, if all the Trustees thereto agree to consider matters on emergency basis.
- 31) All such meetings shall be held at Hyderabad or at such other places as the Trustees may decide from time to time.

- 32) The Trustees are entrusted for maintaining proper accounts showing all receipts, and disbursements made on account of the Trust to be kept and shall be responsible to prepare Receipts and Payment Account, Income and Expenditure Account and Balance-sheet as on 31<sup>st</sup> March of every year and shall be duly audited by a qualified Chartered Accountant.
- 33) The Trustees shall have power and shall be entitled to collect, recover and receive dividends, rents, profits interest and other income of the Trust Estate (hereinafter referred to as the "Trust Income") and to pay there out all taxes, rates, assessments, expenses and outgoings for a collection in respect thereof and for the management of the Trust Estate and for administering and carrying out the trust thereof.
- 34) The Trustees shall have full power to delegate powers as they can lawfully delegate to any person and to execute such instruments as they may think fit for the purpose.
- 35) The Trustees shall have the full power to withdraw any power or revoke any appointment of any employees or attorney.
- 36) The Trustees shall have power to maintain, support trusts and other institutions having objects similar to those of this Trust.
- 37) In case of any dispute arising among the Trustees touching upon day to day affairs of the Trust, the opinion of the majority of Trustees shall prevail and be binding on all the Trustees. If such disputes touching upon either interpretation or validity or enforceability of the terms and conditions set out in this Trust Deed resulting in any deadlock in the affairs of the Trust, the same shall be referred to a mutually agreed sole arbitrator (who is no less than the rank of retired High Court Judge) for resolution of such disputes, whose Award shall be final and binding upon the Trustees. In the event of the Trustees failing to mutually agree upon the name of the sole arbitrator within 30 days of notice of the dispute, the provisions of the Arbitration and Conciliation Act, 1996 shall be applicable for appointment of the Arbitrator by the Hon'ble Courts and such Arbitration Proceedings shall be conducted in English. The place of Arbitration shall be at Hyderabad only. The Courts at Hyderabad only shall have jurisdiction.






